

Guide for students applying for provisional registration while completing the Master of Professional Psychology at University of Melbourne

Step 1	Create an Ahpra online account
Step 2	<p>Login to your account and start an application for provisional registration</p> <p>You can save and return to your application at any time. You may also find these tips for completing your application helpful.</p>
Step 3	<p>Please pay particular attention to the ‘Qualification for the profession’ section of the application (see example on next page)</p> <p>Under the heading ‘Most recent or primary qualification and examinations/assessments’: </p> <p>At ‘Name of Institution’ select ‘University of Melbourne’</p> <p>At ‘Title of Qualification’ select ‘Graduate Diploma in Professional Psychology’^{*^}</p> <p>You do not need to attach copies of your qualification certificate and academic transcript. The University will provide the required evidence directly to Ahpra on your behalf.</p> <p>At the drop-down menu ‘Which pathway are you applying to undertake?’ select ‘Combined 4th + 5th year’</p> <p>At ‘Name of Institution’ select ‘University of Melbourne’</p> <p>At ‘Title of Qualification’ select ‘Master of Professional Psychology’</p>
Step 4	<p>Review your application summary, make your payment and submit your application.</p> <p>We will let you know via email when we have assessed your application. If we need any further information, we will contact you.</p>

Which pathway are you applying to undertake? *

Combined 4th + 5th year

Registration as a provisional psychologist under the combined 4th and 5th year program pathway is dependent on the Board being satisfied that the applicant:

- meets the mandatory registration standards
- has completed an accredited four-year sequence of study in Psychology, and
- is currently enrolled in an accredited fifth year degree and evidence of enrolment is provided directly to Ahpra by the educational institution.

Following completion of the fifth year degree continuation of provisional registration will be dependent on:

- submission of evidence by the educational institution of successful completion of all components of the fifth year degree and eligibility to graduate, and
- submission of a proposed supervision plan that is consistent with the Guidelines for the 5+1 internship program, which has been agreed to by the provisional psychologist and the principal and secondary supervisors.
